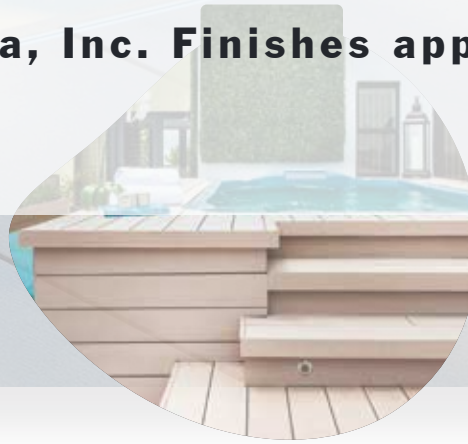


# Novano North America, Inc. Finishes applied to DECKING

**This warranty only applies to Novano North America, Inc.'s finishes applied by its authorized distributors.**

1. Subject to the terms and conditions of this warranty, Novano North America, Inc. warrants that its ArmorTone Decking ("Product"), will be free from peeling, cracking or blistering and significant ultraviolet discoloration caused by natural environmental atmospheric conditions, for a period of FIVE (5) years from the date of the installation of the Product.

2. This limited warranty is not applicable and does not extend to the following:

- I) If damage occurred during delivery, transport or installation of the coated Novano North America, Inc. Decking;
- II) If damage is caused by an external factor, including, but not limited to, stucco leach, acidic or solvent washes, pollen residue or leaf debris, stains, grease, hard tack tapes, persistent salt water spray and blowing sand;
- III) If damage occurred due to an act of God;
- IV) Has been abused, placed under or subjected to abnormal use conditions or has surface damage or surface punctures;
- V) Has been painted, coated, used, modified or otherwise treated in any manner;
- VI) The surface of the Product has been damaged or punctured by any item other than decking installation screws or hidden fastening systems, including as a result of contact with furniture, shovels or sharp-edged tools. Tools should not be used under any circumstance to remove snow, ice or other debris from the surface of the Product.
- VII) Scratches of any kind.

3. Novano North America, Inc.'s sole obligation and the claimant's exclusive remedy under this Warranty shall be limited, at Novano North America, Inc.'s sole discretion, to either (a) the provision of replacement finishing material or (b) a refund, in either case in an amount not to exceed the original purchase price of the finishing material applied to the affected Product. Novano North America, Inc. shall not be liable for, and this Warranty expressly excludes, any costs of labor, removal, reinstallation, refinishing, transportation, delivery, or any other incidental, consequential, or special costs associated with replacing, repairing, or refinishing the Product or its finish.

The warranty period on any replacement finishing material shall be for the remainder of the original warranty period and shall include the same terms and conditions.

Novano North America, Inc. reserves the right to discontinue or change any finishing material. If the original finishing material is not available, Novano North America, Inc. may select and provide a replacement of equal quality and price. Transportation, labor, and application charges are the customer's responsibility and are not included in this limited warranty. The foregoing is the sole and exclusive remedy under this limited warranty.

4. This limited warranty is in lieu of and excludes all other warranties not expressly set forth herein, expressed or implied by operation of law or otherwise, including but not limited to any implied warranties of merchantability or fitness for a particular purpose. To the extent that any implied warranties may nonetheless exist by operation of law, such warranties are limited to the duration provided by law. Novano North America, Inc. shall not be liable for incidental, consequential or special damages of any kind. 1. Subject to the terms and conditions of this warranty, Novano North America, Inc. warrants that its Finishes ("Product"), when applied to its Façade Products in accordance with the Application Instructions issued by the company regarding the Product ("Instructions"), will be free from peeling, cracking or blistering and significant ultraviolet discoloration caused by natural environmental atmospheric conditions, for a period of FIFTEEN (15) years from the date of application of the Product.

2. This limited warranty is not applicable and does not extend to the following

- I) If the Product has not been applied by a certified finisher
- II) If damage occurred during delivery, transport, storage or installation of the coated Novano North America, Inc.'s Façade Products;
- III) If damage is caused by an external factor, including, but not limited to, stucco leach, acidic or solvent washes, stains, grease, hard water build-up, hard tack tapes, persistent salt water spray and blowing sand;
- IV) Scratches;
- V) Irregular use of Façade Products and vandalism;
- VI) If damage occurred due to an act of God;
- VII) Movement, distortion, collapse or settling of the ground or the supporting structure on which the Product is installed; and
- VIII) Damage to Product surfaces, caused by cleaning products, chemicals, ice melting salts, pressure washing, planters, dirt build-up, or ordinary wear and tear.

3. Novano North America, Inc.'s sole obligation and the claimant's exclusive remedy under this Warranty shall be limited, at Novano North America, Inc.'s sole discretion, to either (a) the provision of replacement finishing material or (b) a refund, in either case in an amount not to exceed the original purchase price of the finishing material applied to the affected Product.
